#### **Emergency Temporary Privileges**

Approval for after-hour temporary privileges can be obtained in cases of urgent/emergent patient care needs. In situations where the patient is too unstable to transfer and no specialists on staff at St. Jude Medical Center can assist with your emergency—and you know of a physician or specialist who is willing to come to the hospital—you can request emergency temporary privileges.

The Administrative Resource Nurse (ARN) can assist with this process. Emergency temporary privileges consist of all privileges including treatment, procedures and consults.

- Responsibility for Discharge Summary
  The Bylaws Committee recommended the
  following proposed change to the General Rules:
  The discharge summary shall be completed by the
  designated attending on the day of discharge.
- Medical Screening Examination Requirement
  The following practitioners are authorized to
  conduct a medical screening examination to
  determine if an emergency medical condition
  exists:
  - **a. Labor and Delivery:** Physician members of the medical staff and Registered Nurses who have completed the competency program and are operating under an approved Standardized Nursing Protocol.
