Medical Staff Update

Hydrocodone Combination Productions(HCPs) Change from Schedule III to Schedule II

The DEA has announced it is rescheduling all hydrocodone combination products (HCPs) from federal Schedule III to federal Schedule II effective Oct. 6.

Federal requirements for prescribing and dispensing Schedule II controlled substances will apply to all hydrocodone combination products. This means, among other things, a very limited ability to orally prescribe HCPs and authorize refills. This "up scheduling" is a major change for California. HCPs are the most frequently prescribed opioid in the United States: nearly 137 million prescriptions for HCPs were dispensed in 2013.

The DEA is permitting legitimate HCP prescriptions issued before Oct. 6, 2014 to be refilled until April 8, 2015, if the prescription authorizes refills.
